

PRIVACY POLICY

Privacy Statement

We consider it our responsibility to protect your privacy. Your privacy is as important to us as it is to you. This privacy statement applies to the services of Truck Supply Europe SRL.

- As Truck Supply Europe SRL, we limit ourselves when personal data are collected to only those data that we legitimately and have obtained with reasonable means and if applicable, with the knowledge or permission of the parties involved.
- As Truck Supply Europe SRL, we ensure that the personal data collected by us is limited to the purposes for which they are collected and always with the correctness, completeness and regularity required.
- As Truck Supply Europe SRL, we only collect personal data after the goals of the collection have been sufficiently and made known beforehand, it is clear that the use is limited to the realization of these goals or to other (on a case-by-case basis) targets that are not in conflict with the objectives and purpose for which they were previously collected.
- As Truck Supply Europe SRL, we do not provide personal data for purposes other than those for which they were collected, except on the basis of explicit authorisation from the data subject.

- As Truck Supply Europe SRL, we ensure that every person who reports to us receives an answer to the question of whether we have personal data about him/her, the actual decision about this personal data concerning him/her, this data will not be received in a readable form

for non-excessive payment and if he/she is refused this, this will be refused with stating reasons and the way in which this can be appealed. He/she can challenge the personal data concerning him/her and if successful he/she can require that this personal data will be removed, corrected, supplemented or changed.

- As Truck Supply Europe SRL, we ensure that we are able at all times to be accountable for the way in which we, as an organisation, interpret our privacy rules of conduct.
- As Truck Supply Europe SRL, we ensure that the personal data collected by us is not kept longer than necessary for realizing the purpose(s) for which they were collected.
- As Truck Supply Europe SRL, we do not transfer personal data to third countries until we have assured ourselves that the receiving country guarantees and safeguards the rights and freedoms with regard to the processing of personal data.
- Our website uses 'cookies' (text files that are placed on your computer) to help analyse the website usage so that we can tailor our services accordingly and further improve the user-friendliness. The information, generated by the cookie, about your use of the website can be transferred to Truck Supply Europe SRL's own secure servers. We use this information to keep track of how you use the website, to draw up reports on the website activities and to offer other services relating to website activity and internet usage. Most browsers, by default, are set to accept cookies. You can reset your browser to refuse cookies or to indicate when a cookie is being sent. However, it is possible that some functions and services on our or other websites will no longer function as you are used to if you disable your cookies.
